- ☐ CO AGRICULTURAL LABOR RIGHTS & RESPONSIBILITIES POSTER (#06400, #06401) – Required for all Colorado agricultural employers.
- ☐ CO ON-PREMISES ALCOHOL POSTER – Required in spaces licensed for on-premises alcohol consumption, such as hotels, restaurants, taverns, and art galleries. Small format for general licensees (#06710) and large format for gaming taverns (#06711).
- ☐ CO DRINKING AGE POSTER – Must be posted by Colorado liquor and beer retail licensees. (#06715, #06720).
- ☐ CO PUBLIC ACCOMMODATIONS POSTER – Must be posted in accessible and well-lit places customarily frequented by people seeking services, purchases, facilities, privileges, advantages, or accommodations offered to the general public. Bilingual (#06703).



- ❑ CO HOUSING DISCRIMINATION POSTER – Must be posted by real estate brokers or agents, home builders, home mortgage lenders, and all other persons who transfer, rent, or finance real estate. Bilingual (#06717).
- ❑ CO WORKERS' COMPENSATION FRAUD POSTER – Recommended poster. English (#06300)
- ❑ CO DENVER CITY & COUNTY ANTI-DISCRIMINATION POSTER – Posting is required by every employer operating in the City or Count of Denver and employing 20+ employees. Available in English (#06705) & Spanish (#06706).
- ❑ CITY OF DENVER MINIMUM WAGE POSTER – Updated annually and required for employers with employees working within the City of Denver four or more hours per week. Bilingual. (#06716)
