- ❑ MASSACHUSETTS UNEMPLOYMENT INSURANCE BENEFITS PAMPHLET – Employers must provide a copy to all employees who are separated from work, permanently or temporarily, as soon as practicable. (#21706 EN, #21708 SP)
- ❑ MASSHEALTH PHARMACY COPAYMENT – Pharmacies who offer MassHealth co-payment services are required to display this poster. (#21200)
- ❑ MASSACHUSETTS TEMPORARY WORKERS RIGHT TO KNOW – Staffing agencies are required to display this poster.
- ❑ NO SMOKING – The Massachusetts Smoke-Free Workplace Law prohibits smoking in schools, restaurants and bars, taxis, private offices, and other places of work. This poster must be displayed where smoking is prohibited. (#21702)
